What is the Shawnie Bill?



Placement

It ensures residential service placement within 30 days once the child becomes eligible for placement.



Funding

It creates an emergency fund for placement and payment of a disabled child or adolescent in a residential care facility.



Permission


It gives final authority to the parents or guardians of the child as to which residential treatment facility the child will attend.

THE PROCESS

Supporting a special needs family in crisis is a multi-faceted process that involves numerous steps. It typically begins with an initial meeting with our experienced advocates, where we carefully listen to the family's concerns, needs, and goals. This conversation helps us tailor a personalized plan of action. We guide families through the often complex paperwork and documentation required, which might involve IEPs (Individualized Education Programs), therapy schedules, or medical records, among others. Once the paperwork is organized, our advocates represent the family in meetings with school districts and other agencies, ensuring that their unique requirements are heard and addressed. Throughout the process, we provide unwavering support, offering resources, expertise, and emotional assistance to help the family navigate challenges and achieve the best possible outcomes.


